GRANTS ARE AWARDED BASED UPON NEED FROM THE ANNUAL CAMPAIGN, DONOR RECOMMENDATIONS AND FUND AGREEMENTS. GRANTS ISSUED RANGE FROM SUMMER YOUTH CAMPERSHIPS AND SCHOLARSHIPS TO PRIVATE HIGH SCHOOLS.
