GRANTS ARE AWARDED BASED UPON NEED FROM THE ANNUAL CAMPAIGN, DONOR RECOMMENDATIONS AND FUND AGREEMENTS. GRANTS ISSUED RANGE FROM SUMMER YOUTH CAMPERSHIPS AND SCHOLARSHIPS TO PRIVATE HIGH SCHOOLS. EDUCATIONAL SCHOLARSHIPS ARE LARGELY TO SECONDARY INSTITUTIONS OF LEARNING TO PROVIDE TUITION ASSISTANCE FOR SPECIFIC ENROLLED STUDENTS BASED UPON THEIR ACADEMIC PERFORMANCE AND FINANCIAL NEED AS DEFINED IN THE FUND AGREEMENT, OR BY BOARD APPROVAL. HMMSA HAS IMPACTED OVER 40,000 STUDENTS AND VISITORS ANNUALLY BY ITS PROGRAMS THROUGH SCHOOLS, OTHER ACADEMIC INSTITUTIONS AND THE INTERNET.
