**JOINT RESOLUTION OF THE BOARDS OF DIRECTORS OF JEWISH COMMUNITY PARTNERS, INC., MEMPHIS JEWISH FEDERATION, INC., AND JEWISH FOUNDATION OF MEMPHIS, INC., REGARDING LOANS MADE AVAILABLE UNDER THE CORONAVIRUS AID, RELIEF, AND ECONOMIC SECURITY ACT (CARES ACT)**

Resolution adopted by the Board of Directors (the "Boards") of each of Jewish Community Partners, Inc. ("JCP"), Memphis Jewish Federation, Inc. ("Federation"), and Jewish Foundation of Memphis, Inc. ("Foundation") at the April 1, 2020, regularly scheduled joint meeting of the Boards:

**RESOLVED**, that the Chair, the President and the other duly appointed and elected senior executive staff and officers of JCP, Federation and Foundation (each an "Agency" and collectively the "Agencies"), are authorized to apply for, and that Laura Linder, the President of each of the Agencies, and one or more of Ken Steinberg, Chair of JCP, Cindy Finestone, Chair of Federation, and Anthony Morrison, Chair of Foundation (each Chair being designated hereby as authorized agent for any of the Agencies for this purpose), are authorized and directed to execute and deliver such agreements, promissory notes, or other documents and instruments as may be necessary to obtain and close a loan or loans for JCP, Federation and/or Foundation, as determined to be appropriate by such officers and executives, from the Small Business Administration and/or from a bank or banks that are SBA-approved participating lenders pursuant to the Paycheck Protection Program ("PPP") of the Coronavirus Aid, Relief, and Economic Security Act (the "Act") for such amounts as may be available under the terms and conditions of the Act.
